Criminal Original Petition praying that in the circumstances stated therein and in the affidavit filed therewith the High Court will be pleased to call for the records pertaining to the Impugned Charge Sheet in CC.No.16 of 2021 pending on the file of Judicial Magistrate cum Additional Magistrate Court, Ramanathapuram in FIR in Cr.No.18 of 2018 on the file of the Respondent No.1 dt.18.5.2018 on the file of the Respondent No.1 dated 18.05.2018 for the alleged offences U/s. 147, 294(b), 323 of IPC and Section 4 of Tamil Nadu Prohibition of Harassment of Women Act, 2002 and quash the same against the petitioners as illegal.
