and 04.02.2021 respectively, direct the respondent to issue a Speaking order after considering the reply of the petitioner dated 21.01.2021.

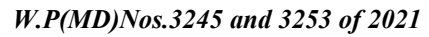

COMMON ORDER

Challenging the impugned orders passed by the respondent as against the petitioner, these Writ Petitions came to be filed on the ground that the impugned orders are cryptic and non speaking orders.

2.The learned counsel appearing for the petitioner drew my attention to the impugned orders dated 08.02.2021 and 04.02.2021 respectively and a perusal of the same would reveal that the same are cryptic orders with just two sentences without elaborating the reasons for initiating departmental action against the petitioner.

3.In view of the same, this Court hereby set aside the impugned orders for sole reason that the same are cryptic and remand back the same to the respondent, with a direction, directing the respondent to consider the matter afresh and pass appropriate orders within a period of 12 weeks
