The case of the prosecution is that on 03.10.2022 at 16.00 hours, based on the secret information received by the Sub-Inspector of Police, he along with the police party went to Kalaigapattinam to Vedapatti Road, where so, they found the petitioner along with other accused to be in joint possession of 540 Kgs of Ganja. The said contraband was seized by the respondent police and sample has also been taken. Hence the case.

3. Learned Additional Public Prosecutor submitted that investigation in this case has been completed and final report has been filed before the concerned Court.

4. In view of the above submission, the petitioner is directed to approach the trial Court for bail without approaching this Court repeatedly.

5. In view of the above submission, this Criminal Original Petition is dismissed with the above said liberty.
