In that murder case, the accused persons were enlarged on bail and the petitioner along with other accused persons assembled with deadly weapon and gave life threat to the defacto complainant. Hence, the complaint.

3. Learned Government Advocate (Crl.side) submitted that the earlier petition seeking anticipatory bail was dismissed by this Court. This petition is filed without any change in circumstances.

4. In view of the above submission, since there is no change in circumstances, this Court is not inclined to grant relief to the petitioner.
