To enlarge the petitioner herein on bail in connection with the case in CC.No.229/2017 before the learned Judicial Magistrate, Pattukottai in Crime No.632/2016 on the file of the respondent police.

ORDER : The Court Made the following order :-

The petitioner/A1, who is facing trial for the offences punishable under

Sections 294(b), 352 and 379 of IPC in C.C.No.229 of 2017 on the file of the learned Judicial Magistrate, Pattukottai, in Crime No.632 of 2016, on the file of the respondent police, seeks bail.

2.The case of the prosecution is that the case is of the year 2016. Earlier, the petitioner was arrested and released on bail. Thereafter, the petitioner did not appear before the trial Court. Hence, Non Bailable warrant was issued on 06.10.2023 and pursuant to which, the petitioner was arrested on 19.09.2023.

3.Heard the learned counsel on either side and perused the material records of the case.

4.It appears that this is the second application for bail and the earlier bail application filed by the petitioner in Crl.OP(MD)No.22905 of 2023 was dismissed by this Court on 29.01.2024. Now, this application is filed by the petitioner without referring the change of circumstances to consider the case.

5.Considering the above facts and circumstances of the case and also considering the fact that there is no change in circumstances, since the dismissal of

the earlier petition, this Court is not inclined to grant bail to the petitioner.
