ORDER

2.Suit has been filed by the plaintiff seeking partition and separate possession against 11 defendants. Among the 11 defendants, the defendants 1 to 3 and 9 and 10 remained exparte. The defendants 4 to 8 admitted the claim of the plaintiff and also filed the statement. Now, it is posted for payment of Court fee. This petitioners remained exparte in the suit. In view of the above said, preliminary decree was passed and final decree proceedings have also been initiated in I.A.No.5 of 2022. Now it is stated to be pending for payment of Court fee by the defendants.
