ORDER

This writ petition is filed seeking for issuance of a Writ of Mandamus to direct the respondents 4 and 5 to consider and dispose of the petitioner's representation dated 25.01.2024 within the time stipulated by this Court.

2. Mr.D.S.Nedunchezian, learned Government Advocate takes notice for the respondents 1 to 5. Considering the nature of the order proposed to be passed, protecting the interest of the sixth respondent, notice to him is

dispensed with. By consent, this writ petition is taken up for final disposal at the admission stage itself.

3. The learned counsel for the petitioner would submit that the petitioner has given a representation dated 25.01.2024 to the respondents 1 to 5 to not to register or alienate the property in S.No.110/10 and 183/17 situated at Kilankadu, Kadaiyanallur, Tenkasi District. Since the said representation is pending, the petitioner has come before this Court. He would further submit that it would suffice if the representation of the petitioner is disposed of by the respondents 4 and 5, on merits and in accordance with law within the time stipulated by this Court.

4. The learned Government Advocate appearing for the official respondents would submit that the representation of the petitioner and other appropriate documents will be considered by the respondents 4 and 5 in accordance with law.

5. In view of the above, without going into the merits of the claim made by the petitioner in this Writ Petition, the respondents 4 and 5 are
