Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue an appropriate writ, order or direction in the nature of a WRIT OF CERTIORARIFIED MANDAMUS calling for the records relating to the impugned proceedings issued by the 4th respondent District Educational officer in Na.Ka.No.850/ A2/2020 dated 05.03.2020, quash the same, and further Direct the 4th respondent DEO to approve forthwith the appointment of M.Alex Joh as B.T.Assistant (Maths) in the petitioner school w.e.f 02.07.2018 with salary and all other consequential benefits.
