2. Heard the learned counsel appearing for the petitioner and the learned Additional Government Pleader appearing for the official respondents. By consent of both parties, the Writ Petition is taken up for final disposal at the admission stage itself.

3. The case of the petitioner is that the petitioner made a representation to the respondents on 10.01.2024 seeking issuance of joint patta. Since the same has not been considered till date, the present writ petition has been filed.

4. The learned Additional Government Pleader appearing for the official respondents submits that the petitioner's representation will be disposed of in accordance with law by the respondents within the time stipulated by this Court.
