2.The learned counsel for the petitioner submitted that the defacto complainant's son is a practising Advocate at Judicial Magistrate, Sathankulam and the Bar Association had passed a resolution as against the petitioner by restraining the Advocates from appearing on behalf of the petitioner herein. Therefore, the petitioner is unable to execute sureties before the Judicial Magistrate, Sathankulam and thereby, the petitioner filed the present petition seeking modification of the said condition.

3.Considering the facts and circumstances of the case, the condition already imposed by this Court, dated 03.01.2024 is modified to the effect that the petitioner shall surrender and execute sureties before the learned Judicial Magistrate, Tiruchendur. Accordingly, this criminal miscellaneous petition is allowed.
