ORDER

This petition has been filed challenging the proceedings in C.C.No.84 of 2022, on the file of the learned Judicial Magistrate, Tirumangalam, Madurai, against the petitioners, under Sections 147, 148, 294(b), 323, 324, 448, 506(ii) and 326 IPC.

2. The grounds raised by the learned counsel appearing for the petitioners are all factual in nature and it requires appreciation of evidence and this Court cannot decide the same in exercise of its jurisdiction under Section 482 of Criminal Procedure Code. It is left open to the petitioners to raise all the grounds before the Court below and the same shall be considered on its own merits and in accordance with law.
