The daughter of the petitioner had gone missing on 29.01.2024. Hence, a complaint was lodged by the petitioner to the second respondent Police on 01.02.2024 and the same was registered in C.S.R.No.93/2024. Alleging that the second respondent has not shown any interest to trace the petitioner's daughter, the present Habeas Corpus Petition is filed.

The learned Additional Public Prosecutor appearing for the respondents submitted that the petitioner's daughter has eloped with one Yugendhar and they have got married on 11.02.2024 under the Special Marriage Act.
