Subsequently, a similar Petition was filed before the Commissioner of Police which was forwarded to the City Crime Branch and the Current Paper in C.C.P.No.3 is pending.

3. The learned Additional Public Prosecutor, on instructions of the Respondent 2, would undertake that they will follow the guidelines of the Circular issued by the Director General of Police, Tamil Nadu/Head of the

Police, Tamil Nadu and the Circulars issued by the Additional Director General of Police, Law and Order and conclude the investigation.

4. Recording the undertakings given by the learned Additional Public Prosecutor, the Respondents 1 to 3 are directed to conclude the enquiry and take appropriate action within a period of 1 month.
