## **ORDER**

This Civil Revision Petition has been filed against the order, dated 10.10.2018 made in CMP.No.13 of 2017 in F.A.S.R.No.138 of 2016 passed by the Circuit Branch of State Consumer Disputes Redressal Commission, Madurai.

Today, when the matter was taken up for hearing, the learned counsel appearing for the revision petitioner would submit that in the execution proceeding, the dispute has been settled and the amount has been given to the claimants and he has filed a full satisfaction memo before the concerned forum.
