This Habeas Corpus Petition has been filed by the father of the detenu seeking to produce the alleged detenu namely Nagulan, aged about 15 years before this Court and hand over the custody to the petitioner.

2. The learned counsel appearing for the petitioner would submit that the petitioner has sent messages through several whats-app groups and that they got an information that his son was at Madurai and they went in search of his son and thereafter, the petitioner and his wife came to Madurai and they have secured their minor son and he has also expressed his willingness to go along with his parents. He would also submit that the missing person is brought before this Court today.
