Prayer in CONT.P(MD).334/2024:

Contempt Petition filed praying that in the circumstances stated therein and in the affidavit filed therewith the High Court may be pleased to punish the respondent / contemnors for their willful disobedience to the order passed by this Honourable Court dated 11.07.2022 in WA(MD) NO.28 of 2022.
