Prayer in WMP(MD). No.4515 of 2024

To extend the time granted to the Adhoc Committee in WP (MD) 16291 of 2023 in its order dated 11.07.2023 for the further period of 2 months and pass such further or other orders as this Honble Court may deem fit and proper in the circumstances of the case and thus render justice.

Prayer :-

Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, direct the respondents 1 to 3 to conduct the enquiry on the representation given on 27.06.2023 and direct the respondents 1 to 3 to conduct the fresh meeting with the presence of all the pangalis (descendants) of the temple for appointing the trustees other than the respondents 4 to 7 and pass such further or other orders as this Honble Court may deem fit and proper in the circumstances of the case and thus render justice.
