2. The case of the prosecution is that, due to previous enmity, on 13.09.2021 at about 06.30 p.m., the accused persons have indiscriminately attacked the deceased with deadly weapons and caused his death. Hence, the case.

3. Heard the learned counsel on either side and perused the material records of the case.

4. It appears that this is the third application for bail and the earlier bail applications filed by the petitioner in Crl.O.P(MD)Nos.6780 of 2023 and 552 of 2024 were dismissed by this Court on 21.04.2023 and 11.01.2024 respectively. Now, this application is filed by the petitioner without referring the change of circumstances to consider the case.

5. Considering the facts and circumstances of the case and also considering the fact that there is no change in circumstances, since the dismissal of the earlier petitions, this Court is not inclined to grant bail to the petitioner.

6. In the result, this Criminal Original Petition is dismissed.
