2.Today(28.02.2024), when this writ petition is taken up for admission, the learned Special Government Pleader appearing for the respondents based on the written instructions, dated 04.09.2023 submits that on the representation of this petitioner, a report was called for from the Inspector of HR & CE Department and the Inspector of HR & CE Department has filed a report before

the Assistant Commissioner, HR & CE Department and the Assistant Commissioner would take a decision within eight weeks.
