2. The learned counsel for the petitioner would submit that since the petitioner is being a woman and took care of her children, due to the condition imposed by this Court, the respondent Police harassed the petitioner.

3. The learned Government Advocate (Crl.Side) would submit that the petitioner is not complying the conditions imposed by this Court even a single day, hence he opposed to modify the condition imposed upon the petitioner.

4. Considering the fact that the petitioner is a woman and she could not able to comply the condition regularly, the condition already imposed on the petitioner is relaxed. However, it is made clear that the petitioner has to appear before the respondent Police as and when required for interrogation.
