However, the petitioner is ready to appear before any other District Police Station.

3.Considering the submission made by the learned counsel appearing for the petitioner, the condition 8(b) imposed on the petitioner vide order dated 15.02.2024 is modified to the effect that the petitioner is directed to appear before the Inspector of Police, Town Police Station, Tiruchendur, daily at 10.30 a.m., until further orders. The other conditions shall remain unaltered.
