However, the petitioners are ready to appear before any other District Police Station.

3.Considering the submission made by the learned counsel appearing for the petitioners, the condition 8(b) imposed on the petitioners vide order dated 15.02.2024 is modified to the effect that the petitioners are directed to appear before the Inspector of Police, Town Police Station, Tiruchendur, daily at 10.30 a.m., until further orders. The other conditions shall remain unaltered.
