J U D G M E N T

This writ appeal is directed against the order dated 09.01.2020, passed by the learned Single Judge in W.P.(MD) No.25111 of 2019.

2. Today, when the matter was taken up for hearing, learned Central Government Senior Panel Counsel appearing for the appellants, on instructions, submitted that pending appeal, the appellants have complied with the directions issued by the learned Single Judge in the writ petition and the representation of the petitioner has already been disposed of as early as on 24.02.2020 and hence, nothing survives for adjudication in this writ appeal.
