The learned counsel appearing for the petitioners submits that the petitioners could not mobilize the amount within the stipulated time as per the order of this Court dated 10.01.2024 made in CrI.O.P(MD).No.357 of 2024 and therefore, they have not appeared before the trial Court and could not produce the sureties. Hence, he seeks time to comply with the condition imposed upon the petitioners.

3. In view of the same, time granted by this Court, vide order dated 10.01.2024 is extended finally for a period of two weeks from the date of receipt of copy of this order, failing which, the anticipatory bail granted to the petitioners shall stand automatically vacated.
