2.The case of the prosecution is that on 23.12.2023 at about 01.15 p.m., the petitioner/accused along with other accused persons restrained the defacto complainant and committed robbery for a sum of Rs.1000/- from him by using knife and also threatened him to kill. Hence, the case.

3.The learned counsel for the petitioner would submit that the petitioner is innocent and he did not commit any offence as alleged by the prosecution and he is in judicial custody from 19.01.2024 and hence, he pray for bail.

4.The learned Additional Public Prosecutor would submit that apart from this case, the petitioner has 16 previous cases, out of which, 5 were murder case and hence, he strongly opposed to grant bail to the petitioner.

5.Considering the previous antecedents of the petitioner, this Court is not inclined to grant bail to the petitioner. Hence, this Criminal Original Petition is dismissed.
