ORDER

The petitioner has filed this writ petition seeking for issuance of a Writ of Mandamus, directing the respondents 1, 4 to 6 herein to remove the encroachments made by the respondents 3 and 7 to 10 in S.Nos. 8/1B2, 8/4B and 8/5 situated at Aadhi Dravidar Colony, Dabethar Shanthai Colony at Thenur Revenue Village.

2. According to the petitioner, on 11.10.2023, he has made a representation to the respondents 1 to 6, requesting to take action for removal of encroachment made by the respondents 3 and 7 to 10. Since no action has been taken by the authorities, the petitioner has filed this writ
