ORDER

The learned Counsel for the Petitioner submitted that the Petitioner had filed this petition seeking to quash the order dated 28.02.2024 issued by the 2nd respondent with a consequential direction to the respondents to grant permission and police protection to conduct the programme namely Aadal Padal to be held on 08.03.2024 in Arulmighu Sri Ayutthiamman Temple “Masi Festival” in the Petitioner's Village namely Vanniyampatti, Srivilliputhur Taluk, Virudhunagar District.

2. The learned Government Advocate (Criminal Side), on instructions of the Respondents would submit that the Petitioner's representation dated 28.02.2024 was rejected. It is also his further submission that the Petitioner has to give a fresh representation to the Respondent Police and on such fresh representation, the Respondents undertake to follow the circular issued by the Director General of Police, Tamil Nadu/Head of State Police Force, Chennai-4,

in Rc.No.007301/General I(I)/2019, dated 09.04.2019. He also seeks payment of appropriate fee for providing Police protection, as per G.O.Ms.No.139, Home (PoI.VIII) Dept. dated 04.03.2019.

3. In the light of the submissions made by the learned Counsel for the Petitioner and the learned Government Advocate (Criminal Side), the Petitioner is directed to give a fresh representation today itself (06.03.2024) before 2.00 p.m to the Respondents. On receipt of such representation, the Respondents shall consider the same in favour of the Petitioner as per the circular of the Director General of Police, Tamil Nadu / Head of State Police Force. Also, the Petitioner shall pay necessary Charges for the Police Personnel as per G.O.Ms.No.139, Home (PoI.VIII) Dept. dated 04.03.2019.

4. With the above direction, this Writ Petition is disposed of. No costs.
