The petitioner as Organizer of the festival shall pay the cost as per the circular of the Director General of Police, Head of State Police Force, Chennai-4, issued in Rc.No.193784/PAC-2/2017, dated 19.03.2019 for police protection.

With the above directions, this Writ Petition is disposed of. No costs.
