It is for this reason, I propose to intervene. I am persuaded to do so because the petitioner has undertaken that he will pay a sum of Rs.2.00 lakhs to TANGEDCO. Once the payment is done, the petitioner's electricity supply shall be restored. The impugned order is set aside and the matter is remitted to the file of the third respondent. The third respondent will hear the petitioner and pass a fresh order dealing with the petitioner's contention. If the petitioner fails to abide by this undertaking to pay a sum of Rs.2.00 lakhs to TANGEDCO, the benefit of this order will stand automatically vacated.

4.This writ petition is allowed on these terms. No costs. Connected miscellaneous petition is closed.
