2.The case of the prosecution is that the petitioner committed penetrative sexual assault on the victim girl. As a consequence, the victim child was pregnant for five months. Hence, the case.

3.The learned counsel for the petitioner would submit that the petitioner is innocent and he has been falsely implicated in this case and the petitioner is in judicial custody from 18.03.2024. Hence, he prays for grant bail to the petitioner.

4.The learned Additional Public Prosecutor for the State would submit that the petitioner committed penetrative sexual assault on the victim girl and thereby, the victim girl was five months pregnant. Hence, he opposed to grant bail to the petitioner.

5.Considering the allegation levelled against the petitioner is serious in nature and the victim girl is aged about 14 years, this Court is not inclined to grant bail to the petitioner.
