PRAYER: Criminal Original Petition filed under Section 482 of Cr.P.C, praying to direct the learned District Sessions Judge, Special Court for the Exclusive Trial for SC and ST Cases (PCR), Srivilliputhur, to accept the surrender of the Petitioner and consider his bail application on the same day on merits in relating to Crime No.13 of 2024 on the file of the second Respondent.

ORDER

The learned Counsel for the Petitioner submitted that the Petitioner is arrayed as A-4 in Crime No.13 of 2024 pending on the file of the Inspector of Police, Mallanginar Police Station, Virudhunagar District and the Petitioner had filed this Criminal Original Petition seeking direction against the learned Sessions Judge, Special Court for the Exclusive Trial of cases under SC and ST (Prevention of Atrocities) Act, Srivilliputhur, to accept the surrender of the Petitioner and consider his bail application in Crime No. 13 of 2024, pending before the second Respondent.

2.The learned Government Advocate (Criminal Side) appearing for the Respondents 1 and 2 would submit that the Petitioner along with three others are alleged to have stopped the two wheeler driven by the third Respondent and attacked him with bare hands and also damaged the two wheeler worth Rs.1000/-. Hence, the case was registered in Crime No.13 of

2024 under the provisions of SC/ST (Prevention of Atrocities) Act, based on the complaint of the third Respondent with the second Respondent.

3.Considering the submissions made by the learned Government Advocate (Criminal Side) and the learned Counsel for the Petitioner, this Court directs the Petitioner to surrender before the learned Sessions Judge, Special Court for the Exclusive Trial of cases under SC and ST (Prevention of Atrocities) Act, Srivilliputhur, within 15 days from the date of receipt of a copy of this order or from the date of uploading the copy of this order in the official web-site of this Court.

4.On such surrender by the Petitioner and on filing an application for bail, the learned Sessions Judge, Special Court for the Exclusive Trial of cases under SC and ST (Prevention of Atrocities) Act, Srivilliputhur, shall consider the bail application of the Petitioner, after issuing notice to the victim of crime/De-facto Complainant and after hearing the objections of the victim of the crime, shall pass appropriate orders as per law.
