Crime No.30 of 2024, on the file of the respondent police, seek anticipatory bail.

2.The case of the prosecution is that the first petitioner borrowed a sum Rs.18,00,000/- from the defacto complainant and subsequently, the defacto complainant demanded the said amount and the same was refused by the first petitioner. Thereafter, the petitioners kidnapped the defacto complainant for committing murder. However, he narrowly escaped and lodged a complaint before the respondent police. Hence the case.

3.Heard the learned counsel on either side and perused the material records of the case.

4.It appears that this is the second application for anticipatory bail and the earlier anticipatory bail application filed by the petitioners in CrI.OP(MD)No.1783 of 2024 was dismissed by this Court on 08.02.2024. Now, this application is filed by the petitioners without referring the change of circumstances to consider the case.
