Prayer :- Writ Petition filed under Article 226 of the Constitution of India, praying for issuance of Writ of Certiorarified Mandamus, calling for the records of the impugned order passed by the 1st respondent in his proceedings in Na.Ka.No.1410/2021/E2 dated 20.03.2021 and quash the same as illegal and consequently, direct the 1st respondent to enhance the award of compensation for having acquired the lands by the 2nd respondent comprising in Punja Survey No.425/2 constituting 3131 square meter situated at Thethupatty Village, Dindigul West Taluk, Dindigul District by taking into consideration of the market value of around Rs.900/- to Rs.1,000/- per square feet of the lands situated in and around the areas.
