Hence, he prays to modify the condition as to appear before the Jigani Police Station, APC Cir Road, Ittina Nagar, Jigani, Karnataka - 560 105, since it is nearby the petitioner's college.

3.The learned Government Advocate (Crl.Side) would submit that the investigation is pending before the respondent Police. If the condition imposed upon the petitioner is modified as prayed by the petitioner, there will be no progress in the investigation.

4.Considering the facts and circumstances of the case and also considering the submissions made by the learned Government Advocate, this petition is dismissed.
