ORDER

The learned Counsel for the Petitioners submits that the Petitioners had filed this Petition to quash the F.I.R in Crime No.153 of 2024 dated 29.02.2024 on the file of the first Respondent Police.

2. The learned Counsel for the Petitioners submit that the Petitioners are arrayed as Accused Nos. 1 to 7. They are native of Kerala State and were studying in Engineering College in Noorul Islam Engineering College, Kumarakovil, since it affect their studies, they have decided to give quitus to the same. During the pendency of this case in Crime No.153 of 2024, the Petitioners herein, who are arrayed as Accused
