Pleased to review the order passed in WP(MD)No. 10496 of 2015 dated 14.02.2023.

Prayer in WP(MD). 10496/ 2015 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Declaration, declaring action of the respondents in discharging services of the petitioner from the Post of Driver on medical grounds with effect from 23.12.1995 and appointing him as Helper as fresh entrant with effect from 21.10.1996 and denying pay protection, continuity of service in the post of driver, as illegal and violative article 14 and 21 of the Constitution of India and consequently to direct the Respondents to extend the benefit of continuity of service, pay protection in the post of Driver with effect from his date of discharge and to re determine re fix his retirement benefits as if he continued to work as Driver from 20.03.1985 to 30.04.2011 and to pay revised retirement benefits to him including monthly pension, gratuity, leave salary and commuted value of pension etc., within the time limit that may be fixed by this court.
