ORDER

Heard both sides.

2.The petitioner challenges the delivery certificate issued by the second respondent in favour of the fourth respondent. It is obvious that the petitioner was having 2-C patta. The learned Additional Government Pleader states that 2-C patta was cancelled. The possession of a person who is paying B memo charges is at sufferance. Of course, the authorities could have adopted due process of law. They have not done so. The learned Additional Government

Pleader informs the Court that for solid waste management, the requisite infrastructure has already been laid and possession has also been handed over to the local body. In these circumstances, I am not in a position to interfere.

3.The writ petition stands dismissed. No costs. Consequently, connected miscellaneous petitions are closed.
