Order : This Criminal Miscellaneous Petition coming up for orders on this day, upon perusing the petition filed in support thereof and upon hearing the arguments of Mr.M.JEGADEESH PANDIAN, Advocate for the petitioner and of Mr.A.THIRUVADI KUMAR, Additional Public Prosecutor on behalf of the Respondent, the court made the following order:-

This petition has been filed to modify the conditions imposed on the petitioner in CrI.M.P.(MD)No.14957 of 2023 on 29.02.2024.

2. The learned counsel for the petitioner submitted that the petitioner did not have any blood relatives and hence, he prayed to modify the condition as regular sureties instead of blood sureties.

3. Mr.A.Thiruvadi Kumar, learned Additional Public Prosecutor appearing for the respondent submitted that he has no objection to modify the condition as prayed for by the petitioner.

4. Considering the submissions of the learned counsel on both sides, the condition No.(i) imposed by this court in CrI.M.P.(MD)No.14957 of 2023 on 29.02.2024 alone is modified to the effect that the petitioner shall execute a bond for a
