This Criminal Miscellaneous Petition has been filed to modify the condition imposed by this Court in Crl.M.P.(MD).No.9512 of 2023 in Crl.A.(MD).No.516 of 2022 dated 07.03.2024, by directing the petitioner to execute two sureties with a bond for a sum of Rs.25,000/- (Rupees Twenty Five Thousand Only) instead of “(i) the petitioner shall execute a bond for a sum of Rs.25,000/- (Rupees Twenty Five Thousand only) with two blood sureties each for a like sum to the satisfaction of the learned Special Court for Exclusive Trial of POCSO Act Cases, Virudhunagar District at Srivilliputhur”.

2.This Court considered the request of the petitioner and directed Government Advocate (Crl. Side) to verify the sureties.

3.On verification, the learned Government Advocate (Crl. Side) submitted that the proposed sureties are genuine one.
