Prayer in Crl.O.P.(MD)No.5775 of 2023 : Criminal Original Petition filed under Section 482 of Cr.P.C., to direct the 4th respondent herein not to harass with threatening to register false FIRs against the petitioner and his family members for threatening to convert from Hindu Religion to Christian acting in favour of respondent Nos.6 to 9 based on the petitioner's representation dated 14.11.2022.

Prayer in Crl.O.P.(MD)No.5797 of 2023 : Criminal Original Petition filed under Section 482 of Cr.P.C., to direct respondent Nos.1 to 3 to give adequate police protection for the petitioner and his family members in the petitioner's house in N.Arulananthapuram Village, Parthipanoor Post, Paramakudi Taluk, Ramanad District from all the illegal acts of respondent Nos.5 to 9 based on the petitioner's representation dated 14.11.2022.

COMMON ORDER

These Criminal Original Petitions have been filed to direct the 4th respondent not to harass with threatening to register false First Information Reports against the petitioner and his family members for threatening to convert from Hindu religion to Christian and acting in favour of the respondent Nos.6 to 9, and to direct respondent Nos.1 to 3 to give adequate

police protection for the petitioner and his family members in the petitioner's house in N.Arulananthapuram Village, Parthipanoor Post, Paramakudi Taluk, Ramanad District by considering the petitioner's representation dated 14.11.2022.

2. Based on the earlier direction of this Court, a status report has been filed by the 2nd respondent herein. On perusal of the same, it can be seen that totally five petitions were received, and five C.S.R. numbers were given. Out of preliminary enquiry since the offences were made out, four cases were registered against the petitioner as well as the other side, and the 5th case was closed.

3. The learned Government Advocate (Criminal Side) submitted that except to conduct the investigation as per the due process of law, the respondent police did not harass the petitioner nor did they registered any false case. The investigation has also been completed, and the final report is also taken on file. The particulars with reference to the said four cases are as follows :
