Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus, calling for the records of the impugned order passed by the 5th respondent herein in his proceedings in Na.Ka.A8/1162/2022 dated 23.01.2024 (Award No. 04/2024) posted on 07.02.2024 and received on 08.02.2024 and quash the same as illegal and further directing the 5th respondent to pass appropriate award by conducting proper enquiry and fix the compensation in accordance with law as far as the land in T.S.Nos. 24/1, 27/2, 40/2, 41/2 and 43/2 in Ward No. 38, C Block, Tenkasi Village and District within a time stipulated by this Honble Court.
