2. Heard the learned counsel appearing for the petitioners and the learned Government Advocate (Crl.Side) appearing for the respondent.

3. When the matter was taken up for hearing, the learned Government Advocate (Crl.Side) appearing for the respondent Police would submit that the petition enquiry is pending against the petitioners.

4. In view of the above submission made by the learned Government Advocate (Crl.Side), the respondent Police is directed to complete the enquiry, within a period of two weeks from the date of receipt of a copy of this order and in the enquiry, if a prima facie case is made out against the petitioners, the respondent police shall register the First Information Report, else the petition be closed.
