ORDER : The Court Made the following order :-

The petitioner, who apprehends arrest at the hands of the respondent police for the alleged offence under Sections 406, 420 and 120(b) IPC and Section 5 of Tamil Nadu Protection of Interest of Depositors [Financial Establishment] Act, 1997, in Crime No.2 of 2020, seeks anticipatory bail.
