2. The Writ Petition in W.P(MD)No.15886 of 2022 has been filed to direct the respondents to disburse the provident fund and arrears of salary totally a sum of Rs.2,34,831/- and basic pay for the period of 2010 to 2012 based on the petitioner's representation, dated 01.04.2022.

3. This Court vide order dated 21.07.2022 disposed of the aforesaid Writ Petition by directing the respondents to consider the representation of the petitioner, dated 01.04.2022 on its own merits and pass appropriate orders within a period of three months from the date of receipt of a copy of the order.
