This Criminal Original Petition is filed to modify the condition imposed on the petitioners in Cr.M.P.No.2584 of 2024 by order dated 13.03.2024 by the learned III Additional District and Sessions Judge, Tirunelveli.

2.The learned Government Advocate (Crl. Side) submitted that though the condition to report before the police was imposed on 13.03.2024, the petitioners have so far not reported before the respondent Police.

3. Recording the submission of the learned Government Advocate (Crl. Side), this Criminal Original Petition is dismissed with a direction to the respondent Police to move an application for cancellation of bail, as against the petitioners.
