3.Heard the learned counsel on either side and perused the material records of the case.

4.It appears that this is the third application for bail and the earlier bail applications filed by the petitioner in Crl.OP(MD)Nos.2360 and 4310 of 2024 were dismissed by this Court on 27.02.2024 and 19.03.2024. Now, this application is filed by the petitioner without referring the change of circumstances to consider the case.

5.Considering the above facts and circumstances of the case and also considering the fact that there is no change in circumstances, this Court is not inclined to grant bail to the petitioner.
