3.The petitioner has made a representation on 24.02.2023 to the respondents seeking to acquire the two meter length of land in Pudukkottai Ullur Panchayat. Since, the said representation is still pending consideration, the petitioner has preferred the present Writ Petition.

4.Considering the facts and circumstances of the case, this Court without going into the merits of the matter, directs the first respondent District Collector to consider the representation of the petitioner dated 24.02.2023 and pass appropriate orders on merits and in accordance with law within a period of twelve [12] weeks from the date of receipt of a copy of this order, after affording opportunity to the parties concerned.

5.With the above direction, this Writ Petition stands disposed of. There shall be no order as to costs.
