2.The petitioner has moved this application on the ground that the account number mentioned in the order dated 06.03.2024 is not in operation.

3.The learned Government Advocate (Crl. side) after verification, submits that the amount may be deposited in A/c No.32860118212.

4.Recording the submission of the learned Government Advocate (Crl. side), the condition in paragraph No.6(a) imposed on the petitioner by this Court in Crl.O.P.
