PRAYER :-

For Bail in Crime No.78/2024 on the file of the Respondent Police.

ORDER : The Court made the following order :-

The respondent police registered a case as against this petitioner in Crime No.78 of 2024 for the offence under Section 392, 397, 506 (ii) of I.P.C and Section 25 (1A) of Arms Act and remanded him into judicial custody on 13.02.2024. Therefore, the

petitioner has filed this petition seeking bail.

2. The case of the prosecution is that the petitioner is said to have committed robbery of Rs.450/- from the defacto complainant and also threatened him with dire consequences.

3. The learned counsel for the petitioner submits that the petitioner is an innocent person and he has not committed any offence as alleged by the prosecution. However, he is languishing in Jail from 13.02.2024.

4. The learned Additional Public Prosecutor appearing for the respondent opposes for grant of bail on the ground that the petitioner is having 20 previous cases.

5. Considering the antecedent of the petitioner, this Court is not inclined to grant bail to the petitioner.

6. Accordingly, this Criminal Original Petition is dismissed.
