2.The first respondent vide proceedings dated 13.01.2024 issued property tax receipt in the name of the second respondent and thus, the prayer sought for in the writ petition no longer survive.

Hence, this Writ Petition is dismissed. It is however open to the petitioner if he is aggrieved by the proceedings dated 13.01.2024 to seek redressal of his grievance by working out his remedy in the manner known to law. No costs. Consequently, connected miscellaneous petition is also closed.
